## ELECTORS OR SEDITION

Who decides Presidential elections — Dominion, Smartmatic, ES&S?  
Or legislatures and electors?

On November 3<sup>rd</sup>, around 11:30 p.m. EST, FOX News channel jumped the gun and called Arizona for Biden while Trump had huge leads in the popular vote in Michigan, Wisconsin, and Pennsylvania, and led in Georgia as well. But overnight, those leads evaporated. In Michigan, watchers claimed a trove of well over 130,000 votes for Biden appeared overnight in

a Detroit voting center at around 4 a.m., all for Biden.<sup>1</sup> In Pennsylvania, Philadelphia simply stopped counting ballots on election night, supposedly returning to the counting of mail-in ballots the next day and giving the lead to Biden (now standing at over 80,000 votes, or 1.2


percent, conveniently avoiding the automatic recount at 0.5 percent discrepancy).

### Badges of Fraud


The IRS uses a term to describe situations which appear abnormal enough to indicate that tax fraud or evasion is occurring. That term, “badges of fraud,” certainly describes what Americans have seen with respect to the presidential election of 2020. For

**CAUGHT IN THE ACT:** A clip taken from CNN reporting on election night shows that within 40 seconds, a vote flip from Trump to Biden occurred for Pennsylvania. Note that the time stamps in the lower right corner of the screenshots are a **countdown** to when the polls close, thus 50:47 (below) is *later* than 51:24 (above). Trump first was reported as having 1,690,589 votes, this was reduced to 1,670,631. Biden first was reported as having 1,252,537 votes, this was increased to 1,272,495. Notice that this resulted in an exact percentage switch, too. Biden gained 0.6% of the vote, Trump lost the exact same amount. The flip of 19,958 votes (do the math yourself!) results in a total swing of 39,916 votes in Biden’s favor, or 1.2% of the vote. Is there really any question that the Pennsylvania results for Biden, where the totals are still reported as Biden in the lead by 1.2%, cannot be trusted?

example, Georgia officials also stopped counting ballots for several hours in Fulton County at the State Farm Arena, due to a supposed leaking water pipe (not in the counting room) which only took an hour and half to repair, and never endangered any ballots. The Georgia Republican Party chairman revealed that the Fulton County elections officials told the media and Republican observers that they were shutting down the tabulation at 10:30 p.m. election night, and continued counting in secret until 1:00 a.m.<sup>2</sup>

These are just a few badges of fraud. Hundreds of eye witnesses have signed affidavits describing fraudulent ballot counting techniques. In both Nevada and Georgia, systems were put in place to allow mail-in and absentee ballots to be accepted without proper signature matching with the poll books. This type of fraud alone, if overturned, would likely cause Trump to win the popular vote of those states.

**M**eanwhile, Big Media and Big Tech — that is, all the mainstream media, as well as Facebook, Twitter, and Google — have suppressed, deleted and censored all reports of possible fraud. “Fact checkers” have worked overtime in spinning and explaining away the obvious badges of fraud occurring before Americans’ eyes. Even worse, establishment Republicans like Mitt Romney have accepted Biden as the “president-elect” before any votes have been certified and the presidential electors have voted. A full court press is on to force Americans to accept massive fraud and a senile globalist as president.<sup>3</sup>

Apart from overnight ballot dumps, and convenient counting of mail-in ballots without auditing and verifying signatures, however, the elephant in the room is the electronic voting systems and software used in most States. Two companies, Dominion and ES&S (Election Systems & Software) supply the majority of the machines and software used by the States. And it is the electronic systems which can easily be programmed or hacked to provide the results desired by corrupt officials. On this page and the next page are two examples, caught on video, of vote flipping from one candidate to another within seconds, a badge of fraud which points to interference with software. It is entirely possible that such vote flipping oc-

## Vote flipping: caught in real time!



**IT HAS HAPPENED BEFORE:** In the Kentucky gubernatorial race November 5, 2019, which used ES&S electronic voting, the updated numbers coming in appeared in the upper box, while the previous numbers, shown in the ribbon below, lagged behind in updating and showing the new numbers. The frame reflecting both the new and old numbers appeared for a split second, but by recording and slowing the speed, the above frame was captured, showing the exact moment the flip was reported to the networks. Notice that 560 votes were subtracted from GOP incumbent Bevin and given to DEM challenger Beshear. This was a total swing of 1,120 votes in favor of Beshear, 22 percent of the votes by which he “won” (5,086). Notably, Republicans won every other statewide race on the ballot.

Since Kentucky does not allow for recounts by law, Bevin requested a “re canvass” of the vote totals, which involves merely rechecking the “vote totals” as reported by the machines in each county. The re canvass was completed in six hours, and only one vote changed. Clearly, the vote flipping shown above was never accounted for. Last year, the pressure on Bevin to just accept the results and move on was strong; in the 2020 presidential election, we are seeing exponentially increased pressure of this type on Trump and his team.

curs on a massive scale, but is rarely uncovered. The globalist fascists who run Dominion, used in 30 states, for example, and a related company called Smartmatic, have systems that are hackable in ways that change the vote totals on the counting machines and servers themselves. The only method to catch such software fraud is to hand count all ballots scanned by the machines, and compare them to the totals shown by the machines. This rarely happens.

### Software to destroy nation states

**I**n 2014, the Clinton Global Initiative’s DELIAN Project — “Democracy through Technology” — was created to supply electronic voting technology to certain targeted nations, and Dominion donated automated voting machines to the project. This voting system was used in color-revolution style destruction of political systems and reconstruction under a technocratic new world order. In other words, the goal of such “philanthropy” is to install globalist pawns who will betray their nations to the world government.<sup>4</sup>

In the Philippines, when George Soros’ pawn Be-

nigno Aquino III was declared victorious in 2010 despite the lack of popularity he held among the people (similar to what is happening now in America with respect to Biden), a forensic analysis was conducted of the Smartmatic voting machines used. Computer Specialist Al Vitangcol III found that all systems were hackable through several paths:

1) hacking the memory card to infuse negative votes for one candidate or positive votes for another, 2) using the console ports and USB ports at the back of the counting machines which Smartmatic claims only existed for diagnostic purposes but which Vitangcol proved could allow a regular laptop to connect and influence the votes and software with a regular serial cable and requiring no passwords or usernames. Finally, the hacking of servers themselves containing the transmission of electoral information as was the case in the 2020 USA elections was revealed to be remarkably easy for skilled hackers on Vitangcol's team. <sup>4</sup>

**T**he key figure controlling Smartmatic is Lord Mark Malloch Brown, a former vice chairman of George Soros' Investment Funds (2007), as well as Soros' Open Society Institute and World Economic Forum, former World Bank VP (1995-1999), UN Administrator for Development (1999-2005), UN Deputy Secretary General and UK Minister of State for Africa, Asia and the UN (2007-2009). In short, he is a globalist.



In 2005, Smartmatic acquired Sequoia Voting Systems in California, and became "one of the top U.S. election technology and services provider." It claimed to have employed 57,000 voting machines in the U.S. over the next ten years, and configure 392,000 electoral devices in 16 states, including Michigan, Wisconsin, Pennsylvania, Nevada, and Arizona — key states in the current election cycle. Dominion appears to have acquired the Sequoia (Smartmatic) machines and is also active in Georgia, making Dominion the voting machine and software provider at the heart of the swing states where vote-flipping and stealing occurred. (See, e.g., 6000 votes discovered to have flipped from Trump to Biden in Antrim County, Michigan). Meanwhile, Smartmatic has recently scrubbed all history of Malloch Brown and its involvement in American elections from its website. Another badge of fraud.<sup>5</sup>

So the same fraudulent system used in other countries to deliver them up to the new world order is in play here. And as events have unfolded, it is clear that many Republicans will back the stealing of the election from Trump as well.<sup>6</sup>

### Sedition against the electoral system

**V**ote fraud is sedition. Sedition is defined in 18 U.S.C. § 2384 as "conspir[ing] to overthrow, put down, or to destroy by force the Government of the United States."





The government of the U.S. is the constitution, and it requires that electors appointed by the States vote for the President of the United States. By law, the date for those electors to meet and vote for President is December 14th.

**A**rticle II, Sec. 1, Cl 2 of the U.S. Constitution states: "Each State shall appoint, in such Manner as the Legislature thereof may direct, a Number of Electors, equal to the whole Number of Senators and Representatives to which the State may be entitled in the Congress..." The Supreme Court has acknowledged that the term : "appoint" extends a broad discretion to State legislatures as to the manner of selecting electors. Accordingly, most States today select the electors based upon the winning political party in the presidential election, and a "winner takes all" mentality has prevailed.

What happens when a winner of the popular vote is in dispute, as is present in the current election? States have until December 8<sup>th</sup> to certify the results of the presidential election (after canvassing the vote totals); if no certification is reached, then Congress resolves the dispute before the electors vote.

Keep in mind that vote certification is also subject to corruption, including intimidation by seditious to force otherwise honest people to certify election fraud. This recently happened in Michigan, where Wayne County's (which includes Detroit) board of canvassers' Republican members first voted not to certify the results, but then backed down and voted to certify while recommending that the Democrat Secretary of State conduct an audit of the unexplained discrepancies!<sup>7</sup> The intellectual dishonesty this repre-

sents is stunning — how can vote results be certified if they need to be audited?

Meanwhile, the Michigan legislature, controlled by Republicans, held hearings and is investigating the election. Some Republican legislators have asked the Secretary of State to fully audit the vote before certifying.

**I**f the results are not certified by State deadlines, the legislatures can appoint a new slate of electors. And they should. After all, if the race is so close, why shouldn't Republicans comprise half of the electors?

The corrupt Mich. Senate Majority Leader Shirkey stated: "I do think we're going to find holes in our elections law, particularly this new reality of the mail-in vote ... In that entire analysis, I don't expect it to change the result in Michigan."<sup>8</sup> Shirkey is really saying he will shirk his duty, and fail to lead the legislature to appoint electors where the election outcome is in doubt.

The "winner takes all" electoral appointment system should be swept into the dustbin. Nebraska and Maine do not assign electoral votes this way; why should the two main political parties be allowed to control elections in this fashion? The danger of this is evident when establishment Republicans are as globalist and inimical to the will of the people as the Democrats. This is how rampant fraud designed to oust a populist president and install a communist beholden to the technocratic oligarchy controlling the world is now succeeding.

The Republican controlled legislatures in the swing States where fraud is rampant should do their duty, investigate, and appoint electors accordingly. That is our nation's system, and it is one that is fast being overrun by the global elite. Time is running out, all certifications in contested states are due during the time from November 20 through December 1. Who will step up? Who will resist?
