The **PUTSCH** and the **PURGE**

Part II The Purge

PURGE, *verb transitive* [Latin *purgo*]

To remove what is offensive, to sweep away impurities. To remove elements or members regarded as undesirable and especially as treacherous or disloyal.

In 1966, the devastating economic ruin and millions of lives lost due to the communist policies of China's tyrant Mao Zedong were beginning to become evident to the Chinese, and Mao had to step up his Marxist chaos to maintain control. Mao instigated a 'cultural revolution,' carried out by youth in their teens and early twenties — the Red Guards. The goal of the 'revolution,' as described by an *LA Times* reporter in 1985, was to "eradicate all vestiges of what they called 'the four "olds"'— old ideas, old customs, old culture and old habits."¹ And so, the Red Guards burned books, toppled statues, terrorized the community, and set the example for the Black Lives Matter (BLM) and Antifa youth of today, who rely on neo-Marxist ideology to justify their violence.²

Red Guard thugs kidnapped 'landlords' and 'capitalists' to blame for the ruin of their country and publicly humiliated their victims in so-called 'struggle sessions,' where the kidnapped would be made to hang their heads or kneel with placards around their neck containing their names crossed off (as if they were criminals). During these public shaming sessions, mobs would chant communist slogans to 'reeducate' these domestic 'enemies.'

In 2020, the neo-Marxist revolution being foisted on America showed its Red Guard colors as paid BLM and Antifa thugs toppled statues and destroyed businesses already ravaged by economic lockdowns imposed in the name of COVID. BLM mobs publicly shamed those who refused to 'bend the knee' in solidarity with their incoherent ideology. These useful idiots serving the global new world order — *a.k.a.* the 'great reset' — are repeatedly allowed by police and prosecutors to destroy at will with little repercussion. Now that the electoral putsch has occurred, placing a

senile globalist beholden to China in the presidential spot in America, a new reign of terror is underway against *all* defenders of the Constitution. *That* 'old' idea and custom must be eradicated, along with anyone who still clings to it,³ in order to destroy any op-

position to the communist world government desired by big bankers and big business.

The false flag violence instigated by Antifa types who preplanned their activities to coincide with the Trump supporter rally in Washington, D.C., on January 6, 2021, provided the excuse that the globalists need to fast-forward their purge of the old customs of America. They are now moving swiftly to demonize the half of Americans who still believe in free markets and speech as domestic terrorists. The purge is underway, complete with public shaming, the snitch society, and ultimately, prosecuting dissenting opinions as ‘hate’ speech and terrorism.

Demonizing dissent as incitement

Because the Trump administration was too weak to utilize the Insurrection Act to investigate and halt the election fraud of November 2020 and establish that Trump was the duly elected federal president, the traitors of the Constitution struck hard and fast to destroy the election fraud narrative, and to demonize any dissent toward imposter Biden.

The impeachment article introduced on Jan. 11th directly attacked those who believe, with good reason, that the election was stolen. Democrats claimed that Trump “issued *false* statements asserting that the Presidential election results were the product of widespread fraud.” The article further claimed that two of Trump’s statements at the Jan. 6th rally — “we won this election, and we won it by a landslide,” and “if you don’t fight like hell you’re not going to have a country anymore” — directly incited persons who then “unlawfully breached and vandalized the Capitol, injured and killed law enforcement personnel, menaced Members of Congress, the Vice President, and Congressional personnel, and engaged in other violent, deadly, destructive, and seditious acts.”⁴ It must be noted that this statement is false, since no evidence exists of any “rioter” killing any person at all, nor “menacing” a single member of Congress on Jan. 6th.

While the constitutional “high crimes and misdemeanors” reason for impeachment refers to any manner of malfeasance in office, it appears the drafters of the impeachment article attempted to imply that Trump incited rally goes to act to *prevent* the congressional certification of electoral votes. 18 U.S.C. § 2383 makes it illegal to

“incite” an insurrection “against the authority of the United States or the law thereof.” 18 U.S.C. § 2384 makes it illegal to “conspire to ... by force prevent, hinder, or delay the execution of any law of the United States.”

Certainly, Trump desired that Pence would be influenced by the number of Americans who gathered in the Capitol on Jan. 6th to consider, at a minimum, that seven States had submitted competing electoral votes, and to send the matter back to the States for clarification of those votes, as members of State legislatures had requested by letter. Pence committed sedition instead, and counted questionable and contested electoral votes in the manner desired by the anti-Trump uniparty. Nevertheless, Trump’s speech did not request or urge any violent act, insurrection, or sedition be performed by anyone on Jan. 6th.

Freedom precludes incitement charges

The First Amendment guarantees Congress will make no law abridging freedom of speech and peaceable assembly. As economist Murray Rothbard pointed out in *For a New Liberty*, incitement can only be considered a crime if we deny man’s freedom of will and choice, and assume that what one person urges another to do, the other is bound to do. Obviously, a person who gives a speech, without any previous planning or conspiracy to commit a crime with those to whom he is speaking, is exercising freedom of speech, and should no more be responsible for the

actions of those who hear that speech than gunmakers are liable for the actions of those who buy their guns.

Despite the guarantee of the First Amendment, the Supreme Court has carved out an incitement exception to free speech. In *Brandenburg v. Ohio*, 395 U.S. 444 (1969) the Court stated “the constitutional guarantees of free speech and free press do not permit a State to forbid or proscribe advocacy of the use of force or of law violation *except* where such advocacy is *directed to inciting* or producing *imminent lawless action* and is likely to incite or produce such action.” In other words, directly encouraging an audience to immediately commit specific crimes is held to be a crime. If

this is so, then BLM activists who encourage fellow rioters to “burn this s**t down” ought to be arrested for incitement when rioters burn buildings, cars, and statues. And yet, Marxist activists have *not* been prosecuted for such freedom of speech. At the Senate trial, Trump defense attorneys played video of Members of Congress who have used fighting words in public speeches, and have never been held criminally accountable for it. And yet Trump, who did *not* advocate imminent violent action, was publicly persecuted by the uniparty.

The sham impeachment of Trump was also unconstitutional. On Jan. 26th, the Senate voted 55 to 45 to *reject* a motion to dismiss the impeachment trial on the basis of its unconstitutionality. The Constitution does not provide for the trial of citizens who are not government officials, thus the Senate trial of Trump, conducted Feb. 9-13, was illegal, even before the Senate voted to acquit.

Public shaming of Trump (and supporters)

Representative Jamie Raskin, D-Md., the lead “manager” of the Senate’s show trial, based the claims of incitement of insurrection largely on circumstantial evidence, using *media reports* rather than the testimony of eye-witnesses. In other words, it was a kangaroo trial of innuendo, not a real trial of evidence showing what Trump knew and intended by his speech to the million-strong rally gathered at the White House ellipse on January 6, 2021.

But the true goal of the show trial has been stated succinctly by never-Trumper Jennifer Rubin of *The Washington Post*:⁵ “Winning’ the impeachment trial means removing any reasonable doubt in the minds of Americans that President Donald Trump incited a riot, that he let it continue in desperate attempt [sic] to keep power and that Republicans simply do not care.”⁶ It is the public that must be convinced that claims of election fraud, whether put forth by Trump or anyone else, are unacceptable and persons making such claims will be ostracized and punished. Further, the people must be shamed for exposing the ruling elites’ fraud and violations of the Constitution.

Framed as domestic enemies

MSNBC ‘news host’ Nicolle Wallace and ‘political analyst’ Joy Reid, speaking on January 13, 2021, exemplified the “woke” Marxist ideology now rampant in all aspects of American society,

including the political classes. Inquiring as to what should be done with Republicans who back Trump and his election fraud claims, Reid suggested that the Republican party undergo “de-Ba’athification,” referring to the process by which the 2003 Coalition Provisional Authority of Iraq ordered all Iraq Ba’ath party government workers stripped of their jobs and banned from future public-sector employment. (This, under American law, is considered an illegal bill of attainder.) Reid expressed the wish that Republicans supporting Trump be forever barred from the party. Wallace chimed in, calling the party “corrupted by Trumpism,” which she defined as “criminal sedition” supported by people from the grassroots through the White House.

From November 3rd on, the news media have called any and all claims of election fraud “baseless,” and their allegiance to this lie impels them to call out the “Stop the Steal” movement as sedition. Calls have been made for deprogramming those who believe in America-first policies, a complete betrayal of the free speech/free thought rights of Americans. Eugene Robinson, a *Washington Post* columnist who appeared on MSNBC January 12, 2021, stated, “There are millions of Americans, almost all white, almost all Republicans, who somehow need to be deprogrammed. It’s as if they are members of a cult, the Trumpist cult, and they have to be deprogrammed.” Apparently, Americans must be brainwashed and shamed into the ‘woke’ cult Robinson belongs to.

An infamous tactic of putschists is to accuse their enemy of that for which they themselves are guilty. While they practice sedition (overthrowing the governmental structure through election fraud), they accuse constitutionalists and nationalists — who want to *preserve* the government — of sedition. Accordingly, they repeatedly reframe attempts to rectify

election fraud as attempts to “overthrow” the will of the people (as evidenced by the same suspicious election results!).

Summing up the purge plan: (1) start with “mostly” white people who are the enemy class according to “woke” ideology. (2) Now cue in a staged and organized “riot” at the Capitol on the day of election certification to label anyone concerned about election integrity as “domestic terrorists” (a.k.a. “Trumpers”). (3) Next, publicly shame Trump via a sham impeachment process, and by implication, his millions of supporters. (4) Call up a controlled 9-11 type “independent” commission to ‘get to the bottom of the capitol riot, as Speaker of the House Pelosi is now doing. Just as the 9-11 commission was able to set surveillance goals to ‘combat’ alleged Islamic and international terrorism, any capitol riot commission will be setting more ambitious surveillance goals to ‘combat’ domestic terrorism.

This final step requires the redefinition of concerned Americans as ‘domestic terrorists,’ followed by further stimulation of the ‘see something, say something’ society already underway.



Snitch and surveil

In January 20, 2021, Former CIA Director John Brennan compared Trump supporters to foreign terrorists, claiming the Biden administration would be

“moving in laser light fashion” to try and uncover “insurgency movements.” He described “religious extremists, authoritarians, fascists, bigots, racists, nativists, even libertarians” as insurgents threatening the federal government, and stated that “homeland security, intelligence, and even the defense officials are doing everything possible to root out what seems to be a very, very serious and insidious threat to our democracy and our republic.”⁷

This war on *half* of all Americans, *a.k.a.* Trump supporters, is being carried out by new Defense Secretary Lloyd Austin, who recently ordered the military to select a one-day ‘stand-down’ to address “extremist or dissident ideologies” of military personnel.⁸ This war is being carried out on citizen population by the Department of Homeland Security as well. On January 27, 2021, DHS issued a terrorism bulletin claiming that violent extremists are involved in First-

Amendment protected activities:

Throughout 2020, Domestic Violent Extremists (DVEs) targeted individuals *with opposing views engaged in First Amendment-protected*, non-violent protest activity. DVEs motivated by a range of issues, including *anger over COVID-19 restrictions, the 2020 election results, and police use of force* have plotted and on occasion carried out attacks against government facilities. ... DHS is concerned these same drivers to violence will remain through early 2021 and some DVEs *may be emboldened by the January 6, 2021 breach of the U.S. Capitol Building in Washington, D.C.* to target elected officials and government facilities.⁹

After claiming that persons angry with COVID lockdowns and election fraud may engage in terrorist acts, the DHS explains “How You Can Help.” DHS asks “the public to report suspicious activity, and threats of violence, including online activity, to local law enforcement, FBI field offices, or their local Fusion Center.” “Strengthen your community by standing together against violence,” states the bulletin. Translation: there is only “unity” when you snitch on your neighbors to local or federal cops.

To further effectuate the purge of all dissenters to the putsch, the House and Senate have introduced “Domestic Terrorism Prevention Act[s].” The DPTA of 2021 would set up units within the FBI and DHS to monitor, investigate, and prosecute domestic terrorists.¹⁰ The main group they are assigned to investigate? “White supremacists and neo-Nazis.” If this act passes, surveilling and collecting intel on all Americans — but in particular, white persons that ‘woke’ ideology identifies as the enemy — will strip the last vestiges of the Fourth Amendment protections.

It is clear by now that the goal of the putschists is to demonize at least half of Americans as domestic terrorists who need to be controlled and subjected to Mao-style struggle sessions. Add in, perhaps, COVID ‘deniers’ who ‘need’ to be forcibly quarantined and consider: how close are the many who resist the putsch to being dragged off to concentration camps? We must redouble our efforts to educate and warn our fellow Americans of the cultural revolution threatening our entire way of life.
